If you post your Reply Form in Hong Kong, you may use the mailing label in the Reply Form and need not affix a stamp on the envelope when returning your Reply Form. Otherwise, please affix an appropriate stamp.

If the Company does not receive a duly completed and signed Reply Form from you (or another response from you indicating that you object to receiving the Website Version of Corporate Communications) within 28 calendar days beginning from the date of this letter, i.e. 15 May 2025, you will be deemed, until you inform the Company otherwise by reasonable notice in writing at the office of the Company's branch share registrar in Hong Kong at the above address or by email to 1100-ecom@vistra.com, to have elected to receive all future Corporate Communications by Website Version instead of receiving them in printed form. In that event, when the Company makes a Corporate Communication, it will only send you a notification that the Corporate Communication has been made available on the Company's website.
