### **POSITIVE PROFIT ALERT**

This announcement is made by the Company pursuant to Rule 13.09(2)(a) of the Listing Rules and the Inside Information Provisions.

The Board wishes to inform the Shareholders and potential investors of the Company that, based on the information currently available, the Group is expected to record a significant increase in net profit for the six months ended 30 June 2016 as compared with the corresponding period last year. Such substantial increase in the net profit is contributed mainly by the manufacturing business segment of the Group.

**Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.**

This announcement is made by Mainland Headwear Holdings Limited (the “**Company**”, together with its subsidiaries as the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**Inside Information Provisions**”).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders and potential investors of the Company that, based on the preliminary assessment of the Group’s latest unaudited consolidated management accounts and the information currently available to the Board, the interim results for the six months ended 30 June 2016 of the Group is expected to record a significant increase in net profit as compared with the corresponding period last year. Such significant increase in the net profit is mainly contributed by the increase of the profit of the manufacturing business segment of the Group which is resulted from the increase in production capacity and improvement in cost control in the manufacturing operation in Bangladesh after the implementation of the cost control measures for more than two years.

The information contained in this announcement is only a preliminary assessment by the Company’s management based on the information currently available, which has not been reviewed or audited by the Company’s auditors. The unaudited interim results announcement of the Group for the six months ended 30 June 2016 is expected to be released in August 2016.
